## **THE CONTENT OF THE ENROLMENT FORM**

### **DATA PROTECTION ACT 1998**

For ease of administration and in order to reduce costs data supplied by you will be processed in an automated system. The National Association of Retired Police Officers (NARPO) will use your information for membership administration, to circulate information to members, for provision of marketing services to members and finally to safeguard the rights of members and promote measures for their welfare.

### **Personal Data is never disclosed to a third party**

NARPO will retain your information for a period appropriate for specified and lawful purposes. You have the right to ask for a copy of your information. NARPO may contact you by mail, telephone or e-mail to inform you of any goods or services, which may interest you

Requests for subject access may be made by making written application to the Branch Secretary who will arrange for the information required to be supplied by the Data Controller for the branch.

## **YOUR PAY AND NATIONAL INSURANCE NUMBERS**

The reference on the Enrolment Form to your Pay Number refers to the seven figure number which appears on your last pension advice immediately below your name. This, together with your National Insurance Number, enables the staff in the Payroll Section at County Hall to easily identify your pension record when setting up the payroll deduction for your N.A.R.P.O. subscriptions.

## **ABOUT NARPO**

The National Association of Retired Police Officers (N.A.R.P.O.) has existed since 1919 and is the only organisation concerned solely with retired police officers. Its objects are:-

To safeguard the rights of members and to promote measures for their welfare with particular regard to pensions.'

The Association functions through local branches and the National Executive Committee elected at annual conference. Local branches enjoy independence from central control in providing social and welfare services to members.

Regular meetings are held with the Chief Officer and Superintendents Associations and the Police Federation on matters of common interest. N.A.R.P.O. is recognised by the Home Office and Police Authorities and has representatives on the Board of Trustees of the National Police Fund and the Police Dependants' Trust. Regular meetings are held with Home Office officials and there is access to the Minister of State.

The Public Service Pensioners' Council representing retired Civil Servants, Local Government Staffs and many others was founded by N.A.R.P.O. The Council's activities have resulted in the index linking of public service pensions.

Only N.A.R.P.O. can represent retired officers and widows at national level and an advisory service on police pensions and associated matters is available to members.

N.A.R.P.O. News is a colour printed magazine, published by the National Executive Committee, dealing with a wide range of social and welfare matters affecting members. Each Branch publishes a local Newsletter giving details of local matters affecting members of that particular branch. Both these publications are mailed free of charge to every member quarterly.
